OVERVIEW

This bulletin is to inform you that NKL is now adding a set of five validator cleaning cards with a holder and an instruction page with all bulk (JCM "BNF") bill validating safes. The instruction page explains why, when and how to use cleaning cards. The instruction page also includes an order form for ordering additional cleaning cards. See attached document 801417.

PRODUCTS AND SERIAL NUMBERS AFFECTED

All NKL V1 and V2 safes with JCM "BNF" type bulk validators. First safe to include the cleaning cards: S/N SP2008020013.

VALIDATOR CLEANING CARDS

Use Validator Cleaning Cards to maintain peak efficiency and extend the operating life of your validators. Dirt from currency (especially low value \$1 and \$5 notes) builds up on validator sensors and moving parts. Over time dirt buildup will wear out parts and cause reduced bill acceptance. Regular use of Validator Cleaning Cards between scheduled maintenance calls will remove dirt and keep validators operating efficiently.

Cleans and Removes:

- Dirt
- Dust
- Cigarette Smoke
- Magnetic Oxides
- Oils
- Pollution
- Paper Particles



To Clean Your Validator:

- Open and remove the cleaning card from its pack.
- Log in to make a validated drop.
- Insert the cleaning card. Retrieve the card as soon as it is rejected. Repeat the process two more times, then log out and dispose of the card.
- Repeat with a fresh card for each validator.

VALIDATOR CLEANING CARD ORDER FORM

Use one cleaning card per validator each month.

Use cleaning cards more frequently with heavy \$1 and \$5 bill usage.
